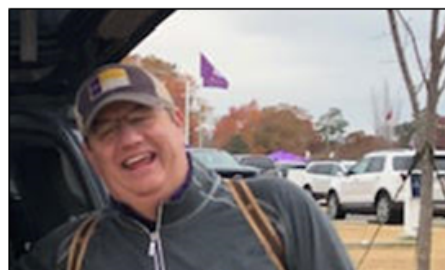
### Why is TKE important to me?

# OPERATION BASEMENT RECON

Recall November's newsletter, Marshall Warren, Scroll 138 volunteered to spearhead our effort to assess the basement for future use options.

**\*\*\* LATEST UPDATE \*\*\***

- A. Contacted the city inspector and unfortunately there was nothing recorded on file as to what might condemn the basement but did obtain key points and next possible steps.
- B. 1st and foremost there have been 4 code changes since we had the house gutted in 2005
- C. Based on the description it sounds like it could be a regress issue.

- D. City Inspector suggested we check ceiling height is 80"
- E. City Inspector stated it must have sprinkler system throughout space
- F. Needs to have heating so sprinkler does not freeze which we have
- G. There needs to be adequate exits and that depends on how many people the basement can occupy. For example if the square footage is 1000' and you have tables, couches, pool table etc. that takes up square footage and exit requirements differ.
- H. Marshall's willing to wager the basement exit leading to the back door is not adequate to be considered an exit.

**\*\*\* FOUR REQUESTS \*\*\***

1. Can someone local please check basement ceiling height?
2. Can someone help find out what it would cost to get blueprints drawn up designed how we want to use that space. It's always been a big gathering space with minimal amenities. Would be curious what other options could be drawn up (e.g., living space, hybrid).
3. We need to eliminate water flow to basement.  
Can someone local get solid estimates on this?
4. Someone contact local company to get a quote on drawings so we can decide next steps - pay for drawings, etc. once drawings are done, and we have determined how the basement will be utilized, we can submit to city inspector for approval.

## SPECIAL CALL-OUT

Servant-leadership is a timeless concept, the phrase “servant leadership” was coined by Robert K. Greenleaf in *The Servant as Leader*, an essay that he first published in 1970. In that essay, Greenleaf said: “The servant-leader is servant first... It begins with the natural feeling that one wants to serve, to serve first. Then conscious choice brings one to aspire to lead. That person is sharply different from one who is leader first, perhaps because of the need to assuage an unusual power drive or to acquire material possessions... The leader-first and the servant-first are two extreme types. Between them there are shadings and blends that are part of the infinite variety of human nature.

The Basement Newsletter was notified last week that multiple brothers noted in the financial snapshot graciously donated \$25,000 in August 2018 but have since decided to forego recovering any of their money given that most-dire time for Lambda Psi Alumni Association.

Maybe a better question is how different was the Teke Experience for the many Eras of Fraters over the 50+ Years of Teke-dom? It is an interesting question... Is it as one of our great Lambda-Psi philosophers, Chip Russell, has said frequently over the years, “Boys will be Boys...” to explain our many excesses. Maybe we can extend Chip’s insight to mean, “Tekes will be Tekes” no matter what year we were born.

### **QUESTION: "Why Teke?"**

**Trevor:** "I had been around ECU for a couple of years and been through a formal Rush. I was an upcoming Junior when I pledged. It was all about joining the REAL Brotherhood there. I knew Jonathan Bennett and I was one of his friends. It had to be real brotherhood there if he was there. I knew there would be a lot of shared memories and I would be building deep friendships. And, yes, I knew also that the fraternity would allow me to build skills and it would look good on my resume.

**Doc:** "I joined Teke because I sensed that unlike the other frats I had visited there was something different about Teke. There seemed to be a closeness/brotherhood there. I am an "only child" and I was attracted to that. Other frats I had visited seemed they were more roommates than brothers. Tekes had these unwritten rules/protocols especially about girls. "You NEVER snake a brother" was one strictly adhered too. Those unwritten rules were put together over time to keep us together.

### **QUESTION: "Other than Brotherhood, was there ONE SPECIFIC THING that made you Go Teke"?**

**Trevor:** "They accepted me for who I am. It was like I was family."

**Doc:** "No one asked me what my family did for a living. Not a single time. Every other fraternity I went too someone would ask; Where are you from? Blah, Blah, blah... What does your Dad do for a living? Tekes didn't care. They accepted me for who I was... I joined a brotherhood."

### **QUESTION: "When you think about Teke what pops in your mind?"**

**Trevor:** "Good parties, loved the parties...But, what I remember is the time we spent together after the parties. Late night, hanging around talking. I have a lot of good memories about those late-night talks and fun. It was a great feeling being there with my brothers.

**Doc:** "If you have read any of my "columns" in the Basement you'll recognize I have a recurring theme... The TV Room. I loved just sitting there with a roomful of brothers, drinking beer, watching a game, a movie, "The Young and The Restless" and discussing Life, The Universe and Teke. And, those "Walks of Shame" were particularly enjoyable. You shared a lot about your thoughts and sometimes they got stomped on. It was a lot of fun just hanging out. It was some of my best time as an active brother.

**QUESTION:** “What did you do as a Fraternity that you are most proud of?”

**Trevor:** “It was the Cookout for America Charity we sponsored. We planned it for months. We wanted it to be better than the previous one. All the funds went to support the Wounded Warrior Foundation. It was a needed cause and an honorable organization. Everyone worked hard at it. We organized, planned, and it was amazing what we could do TOGETHER. It made us a stronger Brotherhood and it meant something to all of us. We became bigger because of it...”

**Doc:** “I think everyone in my era would point to the “Boxing Tournaments.” It was such an unlikely success since we had to get approval from the University. It took everyone of us along with a bunch of Little Sisters to make it happen. Even the brothers who usually found ways to “coast” along got fully engaged. We all ignored everything else during the tournaments. I’m sure the bar revenue drop in Downtown Greenville was noticeable because we, Tekes, didn’t have time for anything else. I will never forget the feeling we all shared after the last fight of our first tournament. “We did it!” We did become bigger because of it...”

Trevor and I talked about a lot of other things on that phone call. We had never met but there was that connection through our similar Teke Experiences. Yeah, we both had puked our brains out a few times at 951, chased sorority girls, played Inter-Fraternity Sports, gone to Football Games but we had experienced those things almost a half-century apart... **45 years apart** (when my Era talks about our “old” college girlfriends now, we are being literal). But, I think the above brief Q&As proves our “common” experiences and life at 951 easily bridges those years. That Teke Experience is built on all the commonalities that bond us together stronger than the years separate us. So in other words, **Tekes will be Tekes... FOREVER!**

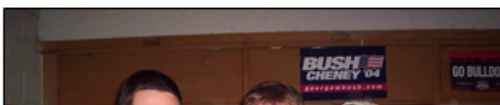
